Question 1 (15 marks)

Awang Yakob and Awang Yasin are jointly charged with the murder of Dayang Yasmin. The police interrogate them separately. During the course of the interrogation by Sergeant Awang Yazid, Awang Yakob said to him:

"I don't know anything about the murder of Miss Yasmin. Try asking Awang Yasin who was always with her. He was in love with her and he had repeatedly proposed to marry her, which she refused abruptly. If any person had a reason to kill Dayang Yasmin, it would be Awang Yasin not me. She wrote a letter to him definitely rejecting his proposal to marry her. You can find the letter in his house."

The following day the police went to Awang Yasin's house and after a search found the letter in a drawer.

Sergeant Awang Yazid subsequently questioned Awang Yasin. He began by saying:

"I know you are an honest and a religious man. You better tell us the truth or Allah will punish you".

Awang Yasin, however, refused to make any statement. Two days later, Awang Yasin's mother is allowed to see him. But before she was taken to see Awang Yasin in the lock up, Sergeant Awang Yazid told her:

"Persuade Awang Yasin to tell the truth for his good, and your own good."

Awang Yasin and his mother were then left alone in the lock-up, where Awang Yasin's mother related to him what Sergeant Awang Yazid had told her. Consequently, Awang Yasin admitted to his mother that he had killed Dayang Yasmin with a knife. However, both Awang Yasin and his mother were unaware that this conversation was being recorded by a hidden tape recorder. The following day the police found the knife at the place described by Awang Yasin to his mother.

- B. Whether Awang Yasin's confession to his mother is admissible?
