**QUESTION 1 (15 Marks)**

(a) Sometimes our society still could not differentiate between “worship” and “customs”.

(i) State four (4) differences between “worship” and “customs” (4 marks)

(ii) State two (2) customs of Bruneian Muslim society which are contrary to Shari’ah. (4 marks)

(b) Define the meaning of *istihadhah* and explain briefly what should be done by a woman who suffers from *istihadhah* when she wants to perform a prayer. (3 marks)

(c) State four (4) differences between semen (*mani*) and urethral fluid (*mazi*). (4 marks)

**QUESTION 2 (15 Marks)**

(a) Define briefly *Sunnah al- Ab’adh* (4 marks)

(b) State the *hukm* with proofs or reasons on the following situations:

- i. Fatimah is sitting while performing *solat ad-Dhuha* even though she has ability to do it by standing.
- ii. Salmah had performed the *Zuhur* Prayer without reciting the opening supplication.
- iii. Villagers saying *Takbir* in the *‘Id al-Adha* during the sunset of the 10<sup>th</sup> Zulhijjah.

(a) Define *Zakah al-Mal* and *Zakah al-Fitr* terminologically.

(b) Briefly discuss the *syuruth* (conditions) on which *zakat al-Mal* is obligatory upon them and explain four (4) recipients of the *zakat al-Fitr*

(9 marks).

(c) *Zakat al-Mal* is obligatory on camels, cattle and sheep/goats. State the amount to be paid in the case of sheep/goats.

- (b) One of the funeral rites is washing the body of a deceased person. Why a martyr is excluded from this rite? Discuss. (1 mark)
