QUESTION 1 (15 Marks)

- (a) Define ablution and describe its *Rukn* (pillars). (3 marks)
- (b) Describe situations where *Tayammum* becomes permissible. (4 marks)
- (c) Certain acts are prohibited during menstruation. Explain those acts in the light of Shariah. (8 marks)

QUESTION 2 (15 Marks)

- (a) Explain the prerequisites of *solat* (prayer). (5 marks)
- (b) State the *hukm* with textual proof or reasons in the following situations:
- (i) Salim had performed the *Fajr* prayer without sitting for *Tashahhud*.
- (ii) Ahmad had a car accident and was seriously injured. Due to the injuries, his doctor had to cast both his legs with plaster and put a bandage on his forehead. Explain how he could perform his ablution.
- (iii) A soldier performing his ablution by wiping over his leather boots while on duty in the jungle.
- (iv) Salmah had performed the *Zuhur* prayer without reciting *Du'a al-Iftitah* (opening supplication).
- (v) Ali had performed his ablution by using water mixed with soap. (1 mark each)
- (c) Explain the *Shurut* (conditions) of *Khutbah* of the Friday prayer. (5 marks)

QUESTION 3 (15 Marks)

- (a) State the jurists' opinions regarding the terms '*Khusuf*' and '*Kusuf*'. (4 marks)
- (b) Briefly describe two methods of performing *Khusuf* prayer. (8 marks)
- (c) State two differences and one similarity between two sermons of '*Istisqa*' prayer and '*Eid* prayer. (3 marks)

QUESTION 4 (15 Marks)

- (a) Define *Zakah* and its textual proofs from al-Qur'an and as-Sunnah. (4 marks)
- (b) Explain five differences between *Zakat al-Mal* and *Zakat al-Fitr*. (5 marks)
- (c) How much *Zakah* should be paid by Ali after 1 year *qamariah* in the following situation:

Money in the bank (at beginning of <i>haul</i>)	: \$50,000
<i>Nafkah</i> of wife	: \$12,000
<i>Nafkah</i> of children	: \$1,200
Profits	: \$20,000
Personal expenses	: \$10,000
Hire purchases	: \$6,000
The price of gold	: \$86 per gram

(d) How much *Zakah* is payable in the following situation:

Salary	: \$24,000
<i>Nafkah</i> of wife	: \$10,000
Personal loan	: \$20,000
Handphone charges	: \$ 600
Astro	: \$660

Water bill	: \$1000
