SECTION 1: QUR'ANIC SCIENCES

PART I (15 MARKS)

- 1) How did our Prophet Muhammad S.A.W. receive *wahy* from Allah S.W.T? Support your statement with evidence either from the Qur'an or from the *Sunnah Nabawiyah*. (5 marks)
- 2) Explain two (2) of the wisdoms behind the gradual revelation of al-Qur'an. (5 marks)
- 3) Discuss four (4) other names of al-Qur'an together with the verses containing each name. (2 marks)
- 4) Define *tafsir* and *ta'wil* according to Imam al-Suyuthy. (3 marks)

PART II (15 MARKS)

- 1) Explain the two sources that the scholars practised in distinguishing the Makkan and Madinan revelations (5 marks)
- 2) Two (2) of the pre-requisites that a *mufassir* must have are to have the knowledge on explaining the Qur'an by the Qur'an and explaining the Qur'an by the *Sunnah*. Elaborate these with examples. (5 marks)
- 3) Define the meaning of *Ulum al-Qur'an*. (2 marks)
- 4) Discuss three (3) characteristics for both *Makkan* and *Madinan* revelations. (3 marks)

- 1) Explain both the literal and technical meaning of *Ulum Hadith* (the sciences of *Hadith*) (2 marks)
- 2) What is the difference between '*ilm Dirayah*' and '*ilm Riwayah*' in the sciences of *Hadith* and how could *Riwayah* help us in understanding the narration? (5 marks)
- 3) Give the explanations of *Hadith* and *Sunnah* in detail. (3 mark)
- 4) There are 2 different views on *Hadith* from the '*muhaddithun*' and jurisprudence, please elaborate. (5 marks)

- 1) State the differences between *Hadith*, *Al- Athar* and *Khabar*, please give one example on each term. (6 marks)
- 2) Give an explanation about "*Sanad Ali*" and "*Sanad Sefli*". (3 marks)
- 3) State only 3 points the Authority of *Sunnah* (*Hujjiyyah Al-Sunnah*) (3 marks)
- 4) What are the 3 main factors relationship of *Sunnah* to the Qur'an (3 marks)
