QUESTION 1 (15 Marks)

(a) Describe three (3) customary wedding ceremonies of Brunei Darussalam which are not permissible in Shariah. Support your answer with proofs from al-Quran or as-Sunnah respectively.

(b) Describe menstruation from medical perspective and explain two prohibited acts during menses in the light of Shariah.

(c) Give four differences between semen (mani) and urethral fluid (mazi).

QUESTION 2 (15 Marks)

(d) Define Sunnah al-Ab'adh and Sunnah al-Hay'at. Give four acts of Sunnah al-Hay'at.

(e) Saiful had an accident on his way to UNISSA. The doctor had plastered his right foot and put a bandage on his forehead. Describe the manner in performing his ablution.

(f) Congregational prayer is highly recommended. Explain the main criteria of an Imam for the prayer based on three (3) authentic *hadiths*.

(g) Since Eidul Fitr was on Friday, Anas had performed Eidul Fitr prayer and missed his Friday prayer. Explain the view of Mazhab Syafie on this matter.

(h) Give two differences between the sermon of *Eid* prayer and the sermon of Friday prayer.

QUESTION 3 (15 Marks)

a) Describe briefly one simple way of performing Kusuf prayer.

b) Syeikh Dr Yusuf al-Qardhawi had issued a statement saying that gelatine or DNA derived from pigs can be considered *halal* if it has undergone a transformation process, according to the Islamic concept, *Istihalah*". Explain the view of *Syafie* scholars on this issue.

- c) How these people should act in the following situations:
 - (i) Siti has irregular menstruation. This month, she had bleeding from her vagina for 18 days. What should be done as regards to her prayer?
 - (ii) Ali forgot to recite prayers upon the family of our Prophet Muhammad (PBUH) after the final *Tashahud*.
 - (iii) Fatimah wants to perform her prayer but forgets to bring her telekung.

(a) Define *al-Zakah*. Give the textual proofs from *al-Qur'an* and *as-Sunnah* to support that it is obligatory.

(c) Discuss the hukm on paying zakat al-fitr on children and domestic helpers.
