### Question 1 (15 marks)

a) Explain the differences between "Contemptuous Damages" and "Aggravated Damages".

b) Amin, aged 31 years, suffered serious injuries at his workplace due to faulty equipment. He cannot work anymore during his lifetime and needs lifetime nursing. Consequently, his wife has resigned from BND 3,000 per month job.

At the time of the accident, he was earning BND 2,500 per month. His trial took five years and at that time the salary of Amin would have been BND 3,500 per month, had he not got injured. He had a life insurance for BND 50,000 and this amount has been paid to him by the insurance company. He used to spend BND 500 on himself every month.

Advise Amin on the quantum of damages under the law applicable in Brunei Darussalam.

b) There was a birthday party at Hassan's house. Karim, a guest, put a white sheet over his body to play a joke. Halima, another guest, fainted when she saw a person covered with a white sheet. Karim carried her into a room and left her there to recover. Hassan saw Karim leaving the room and fearing theft he locked the door.

One hour later Karim went to see whether Halima has recovered. He found the door locked. Karim asked Hassan for the key having explained to him what had happened.

Thirty minutes later Karim and Hassan went to the room and found Halima asleep. Karim shook her. Halima awoke and believing she was being attacked, she struck Karim violently with a stick. Karim suffered head injury.

What torts, if any, have been committed by Hassan, Karim and Halima? Discuss.

In front of the tree there is a notice which states that the berries are poisonous and should not be eaten. Baseer eats some of the berries and falls seriously ill.

Meanwhile, Afroza was walking when a tree-branch hanging over her path fell on her head. She suffers serious injuries. This tree branch has been left carelessly suspended for several months.

Advise whether Baseer and Afroza have got any case against owners of Orchid Garden under the law relating to occupiers liability.

Advise Asrar whether he has a case for defamation against Adnan and Edward. Can Adnan and Edward plead any defence?
