#### **QUESTION 1** (15 Marks)

Ben was moving from his 11th story apartment to a small house. The new occupiers had asked Ben to ensure that all his furniture was removed from the flat. Ben had a very heavy solid oak wardrobe that he could not get down the stairs and the lift wasn't working. Ben looked over the balcony and noticed a group of about 30 teenagers hanging about directly under Ben's balcony. Ben considered that he might cause serious harm but as he did not think that anyone would realise where the wardrobe had come from. Ben was so desperate to get rid of the wardrobe that he decided to push the wardrobe over the balcony. The wardrobe hit one of the teenagers who died in hospital from his injuries.

Ben is charged with murder. State your answer based on both the *actus reus* and *mens* rea of the offence and conclude as to whether Ben is guilty of this offence.

  - (i) Kidnapping; and
  - (ii) Abduction

in the light of leading judicial pronouncements and principles.

## **QUESTION 4** (15 Marks)

Alvin and Charlie are best of friends. One lovely sunny morning Alvin, who was at Charlie's house, took the opportunity to work on a car that he had just stolen. After a while, he noticed from the windows of Charlie's next door neighbor, Elenor, that she was wearing a see-through nightgown. He then realized that the door of Elenor's house was wide open.

Charlie took the opportunity to enter Elenor's house discreetly and took advantage of Elenor by pinning her down and exerted himself sexually on her. Alvin who was at home at all material time was unaware of any of these.

Elenor lodged a police report stating that Charlie had raped her and accused Alvin of aiding Charlie. Medical records however did not show any signs that she was raped.

(i) Based on the provisions of the Penal Code and case laws, advice Charlie whether Elenor has a case made out against him.

(ii) Can the accusation made by Elenor on Alvin stand? Provide your justification based on the Penal Code and relevant case laws.
