QUESTION 1 (15 Marks)

(a) Define "legal system". Explain the objective and the main characteristics of Islamic legal system and give relevant examples.

(b) Distinguish between Shariah and Fiqh. Support your answer with a relevant proof.

(c) Evaluate the importance of the sources of Islamic law in respect of their implementation.

QUESTION 2 (15 Marks)

(a) State a difference between *dharurat* (necessity) and *wajib* (compulsory). Explain the modes of *ijtihad* in solving the problem which arises in the society. Support your answer with relevant proofs.

- (b) Umayyad dynasty has showed the unification of the Islamic Empire and the development of *Fiqh*.
 - (i) State the conflicts which had occurred in the *Umawi* mosque at the beginning of Umayyad dynasty.

(ii) Discuss the negative impact on the development of the process on Hadith compilation in the era of the Umayyad dynasty.

(c) Several factors had led to the evolution of Islamic legal system, during the golden and declination periods of the Abbasid dynasty. Explain the following two factors and their impacts:

(i) Government support towards the development of Fiqh and the Fuqaha (Fiqh scholars); and

(ii) Emergence of different schools (mazhabs) of Islamic law.

QUESTION 3 (15 Marks)

- (a) *Hukum Kanun Brunei* (HKB) was the first written law that was implemented in the 19th century that laid the foundation of the Islamic legal system in Brunei Darussalam.
 - (i) Compare the jurisdictions of Shariah courts according to Muhammadan Law Enactment 1912 and Emergency (Shariah Courts) Order, 1998. Support your answer with relevant advantages and disadvantages from both jurisdictions.
 - (ii) Differentiate the role and functions of a *Qadi* and a *Syar'i* judge in accordance with the Islamic judicial system generally and the Emergency (Shariah Courts) Order, 1998.

(b) Define wakalah bi al-Khusumah. Describe the etiquette of syar'i lawyers according to the concept of wakalah bi al-Khusumah in the light of Hukum Syara'.
