QUESTION 1 (15 Marks)

1. State the answers for the following questions:
 - a) The meaning of fasting. (1 mark)
 - b) 2 evidences from al-Qur'an or as-Sunnah regarding the signs of *Lailatul Qadr* (2 marks)
 - c) 2 benefits of *zam-zam* water from scientific approach. (2 marks)
2. Discuss the following situation and its effect in legal condition:
 - a) Cupping during fasting. (3 marks)
 - b) Using medicine that is injected into the body (2 marks)
3. Define the following underlined terms and discuss briefly:
 - a) One of the pillars of pilgrimage is performing *ihram* from *miqat makani*. (3 marks)
 - b) *Tahallul* is divided into two categories: *tahallul asghar* and *tahallul akbar* (2 marks)

QUESTION 2 (15 Marks)

1. State the differences between the following terms:
 - a) *Haji* and *umrah* (4 marks)
 - b) *Tawaf ifadhah* and *tawaf wida* ' (2 marks)
2. Explain the effects of sexual intercourse on these following worships and support your answer with Qur'anic verses and / or as-Sunnah:
 - a) Fasting (3 marks)
 - b) Pilgrimage (4 marks)
 - c) Iktikaf (2marks)

QUESTION 3 (10 Marks)

1. Define the meaning of *iktikaf* and state its *hukum*. (4 marks)
2. Is a woman allowed to perform her *iktikaf* in the 'mosque' of her house? Suggest your answer with Quranic verses or as-Sunnah. (4 marks)
3. Haziq performed *iktikaf* at al-Aqsa mosque even though he had vowed to do it at an-Nabawi mosque. (2 marks)

QUESTION 4 (20 Marks)

1. *Fidyah* is a compensation payable if a Muslim / Muslimah cannot observe his /her fasting during the Holy Month of Ramadhan due to certain reasons. The amount of *fidyah* is a *mudd* of staple food for each fast missed or $\frac{1}{4}$ of amount of *zakat fitrah* for each person.

If the amount of *Zakat Fitrah* is B\$2.80, how should they pay *fidyah*?

- a) On Ramadhan 1435H, Salmah was not fasting for 7 days due to her menstruation. Then she *qadha* (making up the missed day) it before Ramadhan 1439H. Discuss. (3 marks)
- b) Rahmah was an elderly person who was incapable to perform fasting this year. On 13th Ramadhan she died. Discuss. (2 marks)
2. Explain the steps of performing pilgrimage. (7 marks)
3. State the compensation for the following acts during *ihram*:
 - a) A pilgrimage who cuts his nails and trim his hair. (3 marks)
 - b) Staying overnight at Muzdalifah and Mina. (2 marks)
 - c) Kill a wild cow. (3marks)
