SECTION 1: QUR'ANIC SCIENCES

PART I (15 MARKS)

- 1) *Wahy* was revealed to angels and prophets. Define the modes of *wahy* revealed to our Prophet Muhammad S.A.W, together with evidence from the prophetic tradition. (4 marks)
- 2) Discuss the process of the revelation of the Qur'an with a verse from the Qur'an to support your statement. (5 marks)
- 3) Allah mentions the Qur'an by several names, two of them are *Nuur* (Light) and *Bashir* (Good news). Explain the reasons behind these names. (2 marks)
- 4) Scholars have some debates on some chapters of the Qur'an, whether they are *Makkan* or *Madinan* revelations. Discuss this and elaborate on a chapter as an example. (4 marks)

PART II (15 MARKS)

- 1) Explain the two sources that the scholars practised in distinguishing the *Makkan* and *Madinan* revelations (3 marks)
- 2) Elaborate on *Tafsir bi al-Ra'yi* ; its definition, other name, divisions and example. (5 marks)
- 3) One (1) of the pre-requisites that a *mufassir* must have is to have the knowledge on explaining the Qur'an by the *Sunnah*. Elaborate this and give an example. (4 marks)
- 4) Discuss three (3) characteristics for both *Makkan* and *Madinan* revelations. (3 marks)

1. Explain both the literal and technical meaning of *Ulum Hadith* (the sciences of Hadith). (4 marks)
2. What is the difference between *'ilm Diraayah* and *'ilm Riwaayah* in the sciences of Hadith and how could *Riwaayah* help us in understanding the narration? (4 marks)
3. Give the explanations of *Hadiith* and *Sunnah* in detail. (4 mark)
4. Elaborate the 2 different views on *Hadiith* from the *'muhaddithun'* and jurisprudence, please elaborate. (3 marks)

PART II: (15 MARKS)

1. State the differences between *Hadiith*, *Al- Athar* and *Khabar*, please give one example on each term. (6 marks)
2. Give an explanation about "*Sanad Ali*" and "*Sanad Sefli*". (3 marks)
3. State only 3 points the Authority of *Sunnah (Hujjiyyah Al-Sunnah)*. (3 marks)
4. What are the 3 main factors relationship of *Sunnah* to the Qur'an (3 marks)
